



## **Terms & Conditions – Trade & Food Vendors**

### **Sunday March 22<sup>nd</sup> 2026 – Oakbank Racecourse, Adelaide Hills**

Gates open for Vendors from 7:00am – Open to Public from 10:00am  
NO VENDOR VEHICLE ACCESS TO GROUNDS AFTER 9:00AM

#### **CONDITIONS OF REGISTRATION:**

All food and trade vendors are bound by the following conditions.

1. All vendors must be pre-registered to attend All Ford Day SA 2026.
2. Registration must be completed for each vendor participating in the event via the designated online TryBooking registration system, unless an alternative is agreed to and arranged by the All Ford Day Team.
3. The All Ford Day Team shall be provided with the following information prior to the vendor being directed to the online registration system;
  - a) A copy of Certificate of Currency for their Public Liability Insurance
4. All vendor vehicles, trailers and equipment must arrive at the venue by 9:00am and be ready for operation by 10:00am, when gates open to the public. Entrants arrive from 7:30am.
5. Due to Public Liability and WH&S requirements there is to be no movement of vehicles within the main show car arena from 9:45am till 4pm. A Marshall shall be used in an emergency.
6. Vendors must setup in their pre-allocated positions, as determined by the All Ford Day team.
7. There is to be no oil emptied on the grass or oil residues left. If you require oil for your stall, please ensure that it is disposed of carefully and correctly.
8. Stakes or pegs are permitted if under 25cm in length. If you damage the underground utilities, you will be required to pay for any damages.
9. Any person or persons found to be acting in a manner that may endanger the safety of attendees at the event will be removed from the event and no refunds.
10. All vendors, owners and staff enter and participate in this event solely at their own risk. In consideration of acceptance of this registration to attend All Ford Day SA, the applicant releases the organisers and organising clubs of any and all liability for any loss, damage or injury to applicant, their party and/or their equipment/vehicle(s). By participating in this event, the vendors waive the right of action at law against the organisers, the committee, associated organisers, their representatives or agents for loss, damage or injuries arising from attendance at the function.

#### **Prohibited Items**

11. For the comfort and safety of all patrons, organisers and volunteers, the following items are NOT permitted within the venue;
  - a) Drones, flares, fireworks, firecrackers, smoke bombs and laser pointers
  - b) Alcohol (this is an alcohol free event)
  - c) Animals: other than animals recognised as assistance animals under the Disability Discrimination Act 1992 (Cth) (TA or MOPT, acting reasonably, may request evidence that an animal is an assistance animal and/or is trained to meet standards of hygiene and behaviour that are appropriate for an animal in a public place).
